Health Fair hours: Saturday, March 31, 2012 from 7:30 AM – 12:00 PM

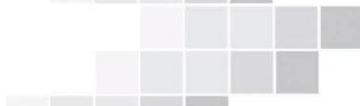
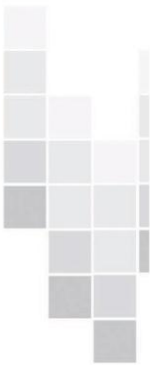
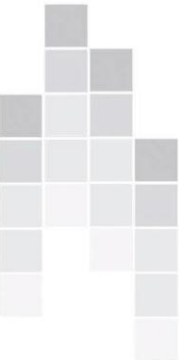

Waiver & Release From Liability

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the "Chasing the Sun" 5K 10K & Health Fair, NABI FOUNDATION, Red Note, Inc., City of Phoenix, State of Arizona, Ak-Chin Indian Community, NIKE N7, Grand Canyon University, MERCK, Native Health & NCAIED and/or its employees, the promoters, other participants, operators, officials, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as releases, from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the tournament facilities, and/or, competing, officiating in, observing, or working for, or for any purpose participating in the event.
